The information from this report will form part of the Global Tobacco Industry Interference Index, a global survey of how public health policies are protected from the industry's subversive efforts, and how governments have pushed back against this influence. The tobacco Industry Interference Index was initiated by SEATCA as a regional report with support from the Bill and Melinda Gates Foundation. The Global Tobacco Industry Interference Index is part of a global publication of the Global Centre for Good Governance in Tobacco Control (GGTC).

### **Methodology**

The TI Interference Index is a civil society report assessing the implementation of FCTC Article 5.3 on the protection of public health policies with respect to tobacco control from commercial and other vested interests of the tobacco industry and its guideline in Vietnam. The index provides evidence on measures and elements that contribute to enabling the tobacco industry to interfere with public health policy making and show how well the government is responding to the challenges posed by TI when applying Article 5.3 guidelines.

This report uses the Tobacco Industry Interference Index Questionaire and scoring guidelines developed by the Southeast Asia Tobacco Control Alliance based on the FCTC Article 5.3 Guidelines. There are 20 questions based on Article 5.3 guidelines. Information used in this report is obtained from the public domain only. A scoring system is applied to make the assessment. The score ranges from 0 - 5, where 5 indicates highest level of industry interference, and I is low or no interference. Hence the lower the score, the better for the country. The 0 score indicates absence of evidence or not applicable.

Information used in this report is obtained from the public domain only which included was limited to information sourced from the official websites, news reports, and tobacco company reports.

The report includes information on incidents from April 2021 to March 2023, but also includes reference to incidents that still have relevance today.

### **Background and Introduction**

The World Health Organization Framework Convention on Tobacco Control (WHO FCTC), the most effective tobacco control measure in the world, is the first treaty negotiated under the auspices of the WHO, with more than 182 Parties to the Convention. As an evidence-based treaty, it reaffirms the right of all people to the highest standard of health and creates a new legal framework for cooperation in the area of tobacco control.

On November 11, 2004 Vietnam ratified the WHO FCTC, which entered into force in Vietnam on March 17, 2005. The objective of the treaty is to protect present and future generations from the devastating health, social, environmental and economic consequences of tobacco consumption and exposure to tobacco smoke.

World Health Assembly resolution WHA54.18 on transparency in tobacco control process, citing the findings of the Committee of Experts on Tobacco Industry Documents, states that "the tobacco industry has operated for years with the express intention of subverting the role of governments and of WHO in implementing public health policies to combat the tobacco epidemic". Therefore, one of the common obligations of the Parties to the WHO FCTC is Article 5.3. "Article 5.3 of the WHO Framework Convention on Tobacco Control protects public health policies with respect to tobacco control from commercial and other vested interests of the tobacco industry". This is a key regulation to protect public health policies from tobacco industry interference.

The Conference of the Parties to the Convention, in decision No. FCTC/COP2 (14) elaborated guidelines for implementation of Article 5.3 of the Convention. The guidelines includes four guiding principles and 8 recommendations:

**Principle 1:** There is a fundamental and irreconcilable conflict between the tobacco industry's interests and public health policy interests.

**Principle 2:** Parties, when dealing with the tobacco industry or those working to further its interests, should be accountable and transparent.

**Principle 3**: Parties should require the tobacco industry and those working to further its interests to operate and act in a manner that is accountable and transparent.

**Principle 4**: Because their products are lethal, the tobacco industry should not be granted incentives to establish or run their businesses.

### **Recommendations include:**

- I) Raise awareness about the addictive and harmful nature of tobacco products and about tobacco industry interference with Parties' tobacco control policies.
- 2) Establish measures to limit interactions with the tobacco industry and ensure the transparency of those interactions that occur.
- 3) Reject partnerships and non-binding or non-enforceable agreements with the tobacco industry.
- 4) Avoid conflicts of interest for government officials and employees.
- 5) Require that information provided by the tobacco industry be transparent and accurate.
- 6) Denormalize and, to the extent possible, regulate activities described as "socially responsible" by the TI, including but not limited to activities described as "corporate social responsibility".
- 7) Do not give preferential treatment to the tobacco industry.
- 8) Treat State-owned tobacco industry in the same way as any other tobacco industry.

Parties to the Convention are encouraged to implement such guidelines to the extent possible, in accordance with national law, without prejudice to national sovereignty in deciding and setting its tobacco control policy.


Vietnam is among the countries with the highest number of smokers in the world, and consequently around 40,000 deaths from tobacco-related illnesses occur each year. The associated economic loss has been estimated at VND 25 trillion/year, almost 1% of annual GDP.

Vietnam passed the Tobacco Control (TC) Law in 2012. The Law consisted of strong policies recommended by the FCTC, including: comprehensive ban on advertising and promotion; prominent pictorial health warnings; smoking ban in public settings; and establishing a TC Fund. Viet Nam has made good progress over the years in implementing tobacco control measures and in reducing smoking prevalence. The prevalence of adults and teens who use tobacco products has gone down. The rate of smoking among adult men went down from 47.4% (2010) to 42.3% (2020) (GATS 2020); the rate of smoking among 13–17-year-olds went down from 4.7% (2013) to 2.7%. (GYTS 2019). These reductions, however, are modest, the male smoking prevalence remains high and has failed to achieve the National TC strategy objective for 2020.

The tobacco industry interference and their front group remain high with the scores of tobacco interference index is above the average while the country is still lacking sufficient measures to protect the policies from commercial and other vested interests of the TI. It is one of the major challenges that hinders progress in implementing and strengthening tobacco control policies to protect public health. Stronger action from the Government is needed in implementing FCTC Article 5.3 to ensure effective implementation of tobacco control measures and in reducing smoking prevalence in Vietnam.

### Cigarette market share in Vietnam

The dominant component of the tobacco industry (TI) in Vietnam is state-owned. The world's three biggest transnational tobacco companies have invested and operated in Vietnam through joint venture and partnership with local companies in production and distribution of their tobacco products. These include: British American Tobacco (BAT), Phillip Morris International (PMI) and Japan Tobacco International (JTI). Figure I shows the main tobacco companies operating in Vietnam and their cigarette market share in 2020.

### **Summary Findings**




Figure 2: Vietnam's Tobacco interference index score 2015-2023

Vietnam has participated in the reporting the Tobacco Industry Interference Index in Vietnam since 2015 and has shown improvement in reducing the scores of the index between 2015-2023, however progress has slowed down in recent years. For 2020-2023, Vietnam scored a total of 57 points while it had 58 points in 2018 and 61 points in 2017 and 72 points previously in 2016 (Figure 2).

### I INDUSTRY PARTICIPATION IN POLICY DEVELOPMENT

Collaboration between the government and tobacco companies in anti-smuggling policy development and enforcement is still in existence. Besides using compulsory contribution from tobacco manufactures for smuggling control of cigarettes, the Government also considered TI as a partner, cooperated with TI in workshops/meetings to discuss solutions to fight again tobacco smuggling. The TI also was proactive in organizing workshops/seminars to do discuss and propose the solutions and regulations regarding smuggling control, and organize training, communication on counter illegal cigarettes at local.

The industry also promotes their recommendations on the issuance of policy to legalize manage new tobacco products (ENDS/HTPs) in Vietnam through media, workshops/meetings and recommendation letters. Even though that there was no direct evidence about the Government accepting the offer of TI for assistance or accepting proposed tobacco control legislation or policy drafted by or in collaboration with TI was collected in Vietnam during this reporting period, but the Vietnam Government has developed and proposed a policy to allow piloting HTPs in Vietnam which is pro TI recommendation. In addition, some policymakers, and lawyers gave speeches at workshops/talk shows/media events supporting the allowing ENDS/HTPs in Vietnam.

### 2 INDUSTRY CSR ACTIVITIES

(Summarize your evidence/ main points in question 5)

The Vietnam Law on Prevention and Control of Tobacco Harms (take effect from May 01 2013) limits Tl's CSR to programs of hunger eradication and poverty reduction; control of natural disasters, epidemic and combating cigarette smuggling, and bans the publicity of such sponsorship in the mass media (Article 16).

The partial ban on CSR activities of TI in Vietnam has seemed to make no difference to the extent the TI continues to conduct these activities. On the one hand, tobacco industry in Vietnam continues their traditional CSR activities in a broad range of donations to schools, construction of schools, construction houses for the poor and heroic mothers, donations to health care facilities, provide gifts for the soldiers, scholarships and gifts for students and program on environment protection etc. On the other hand, they continued to take advance of COVID 19 situation to provide their donation to health sectors, such as: Vietnam National Tobacco Corporation (Vinataba) has donated 100 billion VND to the Civid-19 vaccine Fund, Saigon Tobacco Company: Donated VND 500 million to the prevention and control work of the Covid-19 epidemic etc. The TI'CSR activities usually receive endorsement and participation of government officials from provincial and district level.

### 3 BENEFITS TO THE INDUSTRY

Cigarettes are still sold as duty-free item for international travelers and seafarers working on board a seagoing vessel on international routes.

Beside, Vietnam has extended its 3,000-ton duty-free quota for import of Cambodian dried tobacco leaves for 2022.

### 4 UNNECESSARY INTERACTION

(Summarize your evidence/ main points in questions 8-10)

Since tobacco manufactures in Vietnam is a government monopoly, the management mechanism enable them to have many chance to meet and force relationship with high level government officer from both Central as well as provincial level.

In Sept 2021, Vietnam President had a meeting with the US American associations and investors which including Philip Morris; in Dec 2022, Chairman of the Committee for Management of State Capital at Enterprises had a meeting with the delegation of Philip Morris International Group (PMI) led by Ms. Stacey Kennedy – President of South and Southeast Asia PMI and the Chairman of the Board of Members of Vinataba; in Jan and Feb 2023, on the occasion of the Lunar New Year, the delegation of the Committee for the Management of State Capital at Enterprises led by Vice Chairman of the Committee visited and wished New Year to the collective leadership and staff and employees of the Vinataba; in June 2022, the delegation of the Committee for the Management of State Capital at Enterprises led by Chairman of the Committee came to work at the Saigon Tobacco Company to grasp the operation situation in the first 5 months of 2022 and deploy tasks in the following years.

The Government also gave honor award to the tobacco enterprises for the contribution and achievements, and joint the events to award. Such as: in 2021, Saigon Tobacco Company received a certificate of merit from the Chairman of the Ho Chi Minh City People's Committee on high achievements in the payment to the State budget in Ho Chi Minh City; in 2022, BAT Vietnam was honored to be in the "Top 100 Sustainable Enterprises in Vietnam" in a program announced by the Vietnam Federation of Trade and Industry (VCCI) and Ministry of Labour, Invalids and Social Affairs; in June 2022, the Trade Union of Thang Long Tobacco Company received the excellent emulation flag from the Vietnam Industry and Trade Union, etc.

Besides, collaboration between the government and tobacco companies in anti-smuggling enforcement is still in existence, which facilitates interaction.

### **5 TRANSPARENCY**

The government sees interaction with the tobacco industry as "normal", so they are "open" about their interaction with tobacco industry. However, the detailed information on this interaction (with tobacco and other industries as well) were not always be available for public. The government also does not have procedure for the disclosure or registration of tobacco industry entities, affiliated organizations, and individuals acting on their behalf.

### 6 CONFLICT OF INTEREST

No new appointment of government official to tobacco industry. The appointment of staff from Ministry of Industry and Trade to VINATABA which happened in 2014 still remains in office and were promoted in 2020 (Mr. Ha Quang Hoa-Deputy Director of Department of Light Industry was appointed to be Vice Director of VINATABA in 2014, and then was appointed to be General Director of VINATABA in 2020; Mr. Ho Le Nghia, Vice Director of Industrial Policy and Strategy Institute was appointed to be in board member of VINATABA in 2014, become acted as the Party Secretary, and Chairman of the Members' Council of VINATBA in 2018, and in 2020 he re-elected to be the Party Secretary of VINATABA in the new term).

### 7 PREVENTIVE MEASURES

(Summarize your evidence/ main points in questions 16-20)

The government has not put in place a procedure for disclosing the records of the interaction with the tobacco industry, nor adopted or implemented a code of conduct for public officials yet.

However, the Ministry of Health also have efforts in informing TI tactics and preventing the interaction with TI. In 2017, the Ministry of Health issued official dispatch No 6814/BYT-KCB to warn about PMI-funded Foundation for a Smoke-free World Foundation (FSFW) and call to not cooperate with FSFW. In 2021, the Ministry of Health issued official dispatch No. 5680/BYT-KCB to Health Departments of the provinces, cities and hospitals directly under the Ministry of Health on strengthening the implementation of the Law on Prevention and control of harmful effects of tobacco, and accelerating smoking cessation at medical facilities and disseminate information on the harmful effects of new tobacco products (e-cigarettes, heated cigarettes, shisha) and also suggested that units not cooperate with "Fund for a smoke-free world" of Philip Morris International to contribute to the implementation of Article 5.3.

The Ministry of Industry and Trade has a reporting regime and report forms for tobacco enterprises, tobacco supplier, tobacco distributors, wholesalers, and retailers. However, the government does not require the industry to submit information on Tl's marketing, lobbying and philanthropy.

Collaboration between the government and tobacco companies in anti-smuggling policy development and enforcement is still in existence in both national and provincial level. For example:

### a. NATIONAL LEVEL

- ➤ On 23/12/2021, the Standing Office of the National Steering Committee 389 had a working session with the Vietnam Tobacco Association (VTA) on the fight against tobacco smuggling.
  - At the meeting, Chief of the Standing Office of the Steering committee 389 highly appreciated the positive contributions of the Tobacco Association to the fight against cigarette smuggling.
  - The Vietnam Tobacco Association committed to promoting the coordination with the Standing Office in joint activities to fight against tobacco smuggling in the coming time and proposed that the Office of the Steering Committee 389 will cooperate with the Association in the policy amendment proposals, creating motivation to promote anti-smuggling work. 4

➤ On 28/10/2021, in Hanoi, Japan Tobacco International (JTI) Vietnam Company cooperated with the Vietnam Chamber of Commerce and Industry (VCCI) organized the online seminar named

"Counterfeit, smuggled goods and commercial fraud: current situations, and Solutions". The program was attended by leaders of management agencies, experts, associations, and businesses such as the Standing Office of the National Steering Committee 389; Vietnam Chamber of Commerce and Industry (VCCI); Vietnam Directorate of Market Surveillance; General Department of Vietnam Customs; Vietnam Association for Anti-Counterfeiting, and Trademark Protection (VATAP), Vietnam Tobacco Association (VTA), etc.

At the seminar, Ms. Julian, Anti-illicit trade operations manager at JTI Japan Tobacco International, stated that smuggled cigarettes and counterfeit cigarettes are still a growing threat, affecting the intellectual property rights of brands and consumers. Therefore, tightening sanctions and regulations is very urgent and necessary to ensure product quality for consumers' needs.

Representative of tobacco manufacturing enterprises, Mr. Nguyen Triet, the General Secretary of the Vietnam Tobacco Association, stated: "The situation of cigarette smuggling in Vietnam has become more difficult to handle because cigarettes are light, easily transported can avoid tax, and bring high profit. Therefore, it can easily compete with domestic products. So if we are resolute and focus on combating illegal tobacco products, consumers will easily accept switching to legal cigarettes and that will increase the State's revenue." <sup>5</sup>



On 29/11/2022, JTI Vietnam cooperated with the Vietnam Chamber of Commerce and Industry (VCCI), JTI Vietnam held a workshop: "Counterfeit, smuggled goods and commercial fraud: Current Situation and Solutions".

Attending the seminar were leaders and specialized experts from functional agencies, associations, and businesses, including the National Steering Committee 389, the Vietnam Directorate of Market Surveillance, the General Department of Vietnam Customs; the Vietnam Chamber of Commerce and Industry (VCCI), the Anti-Counterfeiting Department of Vietnam, and the Vietnam Standard and Consumers Association (VINASTAS) together with other organizations. Mr. Clarke Adrian, Corporate Affairs Manager of JTI Vietnam called for "effectively educating retailers and consumers about the consequences of selling and buying illegal products" as a crucial part of the solution and that "consumers should be made aware of the penalties they will face for using illegal products and its impact on their health as well as on society."

The General Secretary of the Vietnam Tobacco Association, Mr. Nguyen Triet, suggested that the authorities – especially the market management force - strengthen their control of the domestic market and regularly inspect the wholesale and retail establishments in order to promptly detect

cases of smuggled tobacco trading, strengthen the enforcement against violating organizations and individuals, and at the same time resolutely and thoroughly handle shops dealing in smuggled cigarettes and promote efforts to encourage businesses that say no to smuggled tobacco.<sup>6</sup>

### b. PROVINCIAL LEVEL

Industry and Trade Magazine reported on 06/11/2022: During the year, Gia Lai Province's Department of Surveillance coordinated with the Vietnam Tobacco Association and British American Tobacco Vietnam (BAT) to organize a training program to carry out awareness program for all civil servants and officials of the Department, guiding the implementation of BAT's 555 cigarette brand authentication application on the Digimarc Discover App (on both iOS and Android operating systems), receiving and deploying to both the organizations and individuals trading in the area propaganda items and posters "Say no to smuggled cigarettes" against trading in smuggled cigarettes from the National Steering Committee 389. <sup>7</sup>

No direct evidence about the Government accepting the offer of TI for assistance or accepting proposed tobacco control legislation or policy drafted by or in collaboration with TI was collected in this reporting period, but the MOIT has been developing and proposing a policy to allow piloting/legalizing HTPs in Vietnam which is pro TI recommendation. In addition, some policymakers provided speeches at workshops/talk shows/media events supporting the allowing ENDS/HTPs in Vietnam.

 According to news on E-Commerce Magazine to on 19 April 2022 and on the website of the Ministry of Information and Communications (MOIC) on 17 Nov 2022, the Vietnam Tobacco Association proposed to the Ministry of Industry and Trade to amend Decree 67 to establish a clear legal basis and strictly manage the new generation tobacco products on the Vietnamese market.

Mr. Ho Le Nghia - Chairman of the Vietnam Tobacco Association suggested that "it is necessary to conduct a proper assessment and develop a legal framework before trialing new-generation cigarettes, creating a legal corridor for the supply of tobacco products. Today, new-generation cigarettes are being traded illegally in thousands of retail locations. The Vietnam Tobacco Association is also proposing the Ministry of Industry and Trade to amend Decree 67 to submit to the Prime Minister to establish a clear legal basis and strictly manage... new-generation tobacco products on the Vietnamese market." 8,9

- According to the news posted on the website of the Ministry of Information and Communications on 7/2022, the Department of Industry (Ministry of Industry and Trade) actively urges and gathers collective opinions through close consultations of the National Assembly agencies to report to the Prime Minister after July 2022 on the formulation of a new Decree to replace Decree 67/2013 on tobacco trading, reviewing state management policies for new-generation tobacco products.
  - Under the draft Decree amending Decree No. 67/2013/ND-CP on tobacco trading of the Ministry of Industry and Trade (MOIT), the MOIT proposes: (i) Introducing some definitions of heated tobacco products, electronic cigarettes, tobacco heating devices, cigarette warmers, and e-cigarette solutions; (ii). Promulgating a resolution on a time-limited pilot for heated tobacco and proposing research and evaluation for the management of e-cigarettes as tobacco products.
- On 24/11/2022, Vietnam Law Newspaper, the Ministry of Justice held a workshop on "Addressing concerns concerns for the new-generation tobacco management".
  - Attending the workshop were the Director General of the Legal Department, Office of the Government; Deputy Director of Economic–Civil Legislation, Ministry of Justice; Deputy Director of the Department of Social Affairs, Office of the National Assembly; General Secretary of the Vietnam Tobacco Association; Head of the Law and Democracy Committee, Central Committee of Vietnam Fatherland Front; together with the representatives some related agencies, ministries, and industries.

All opinions provided that it is necessary to approve and regulate the new cigarettes. Many opinions suggested regulating the new-generation tobacco by amending Decree 67, specifically:

Speaking at the workshop, the Deputy Director of the Social Affairs Department, Office of the National Assembly suggested that the Ministry of Industry and Trade should coordinate with relevant ministries to provide a draft Decree amending Decree 67/2013/ND-CP dated June 27, 2013, detailing various articles and measures to implement the Law on Prevention and Control of Tobacco Harms on tobacco trading.

Deputy Head of Standards and Quality Division on Food and Agriculture, Vietnam Standards and Quality Institute, Directorate for Standards, Metrology and Quality, Ministry of Science and Technology of Vietnam, provided that a heated tobacco product is a cigarette made from tobacco that has a separate heating device, which can be identified as another form of tobacco.

The Ministry of Science and Technology agreed with the proposal of the Ministry of Industry and Trade that the management of heated cigarettes should comply with the Law on Prevention of Tobacco Harms and the current legal documents.

Deputy Director of Economic–Civil Legislation, Ministry of Justice, said that the definition of tobacco is relatively open in the Law. Thus, new-generation tobacco products may fall under the definition of tobacco in the Law on Prevention and Control of Tobacco Harms. Mr. Hai assessed: "Through studying the Law on Prevention and Control of Tobacco Harms, besides coordinating with relevant agencies to study, the Ministry of Industry and Trade can add content on new generation tobacco management, including amending and supplementing Decree 67 to meet the management requirements."

- On 13/4/2022 in Ho Chi Minh City, the Vietnam Tobacco Association (VTA) organized a workshop on "Anti-tobacco smuggling: Current situation and solutions" to update the latest information on the situation of tobacco smuggling and propose solutions to effectively improve the situation of tobacco smuggling.

Attending the workshop there were the representatives of the Government Office, specialized agencies of the National Assembly, the Ministry of Industry and Trade, the Ministry of Finance, the Ministry of Health, the Ministry of Justice, and the National Steering Committee for Antismuggling, Counterfeit Goods and Trade Fraud (the National Steering Committee 389), Vietnam Directorate of Market Surveillance, Border Guard, Economic Police, VTA leadership and member enterprises.

At the Workshop, VTA and the delegates proposed: (I) strengthen the awareness program to educate consumers, small traders, and distributors not to participate in smuggling lines; (2) more resources required to tighten border checks and monitor markets in these provinces; (3) deduct a part of the funds from the Tobacco Harm Prevention Fund for the prevention of smuggled tobacco; (4) suggest the Government to come up with a solution to work with Cambodia to solve the situation of smuggled tobacco from Cambodia to Vietnam. For excise tax, businesses have proposed to postpone the raise of excise tax, expected the Government to consider an

appropriate roadmap in line with the orientation scheme of the law-making program for the 15th National Assembly term, which the tax increases should only be considered from 2024 onwards. 12


On 09/08/2022, at the Hilton Opera Hanoi Hotel, Vietnam Tax Consultants' Association (VTCA) cooperated with Vietnam Chamber of Commerce and Industry (VCCI) to organize the seminar: "Special consumption Tax - Harmonizing state budget revenue regulation and business development.

Speaking at the seminar, Mr. Ho Le Nghia - Chairman of Vietnam Tobacco Association:

- Suggested that the functional authorities shall learn to come up with a roadmap for tax increase, the appropriate level of excise tax on tobacco products due to the fact that the Vietnamese market has many different price segments, avoiding creating create opportunities for smuggled cigarettes to increase consumption, leading to tax revenue loss.
- Functional Authorities to study to come up with a roadmap for tax increase, the appropriate level of excise tax on tobacco products due to the fact that the Vietnamese market has many different price segments, avoiding opening up opportunities for smuggled tobacco to increase consumption, leading to tax revenue loss.
- Request the State and relevant agencies to apply stronger and more drastic measures and use a part of the funds from the Tobacco Harm Prevention to promote the fight against smuggled tobacco, thereby increasing revenue from the legal tobacco industry, instead of accelerating tax increases and imposing new levies on legal tobacco products.
- Mr. Young Jae Song General Director of BAT Vinataba Joint Venture Company also shared that special consumption tax SCT should not be leveled up in the next 1-2 years, and suggested that the State consider a reasonable roadmap with steady raise, avoid a shock increase which could cause instability to the market, the business environment or add up the illicit cigarettes as well as social security problems. 13

- Vietnam's Ministry of Industry and Trade (MoIT) has issued Circular No. 06/2022/TT-BCT specifies import quotas for rice and dried tobacco leaves originating from Cambodia that are entitled to special preferential import tax rates in Vietnam for the two years. The total import tariff quotas in 2021 and 2022 from Cambodia for dried tobacco leaves is 3,000 tons per year. Circular No. 06/2022/TT-BCT will take effect from April 15 to the end of December 2022. While the above import tariff quotas for 2022 are applied to declarations registered with the customs authority from January 1, 2022 to the end of December 31, 2022.41,42
- > Khatoco Tobacco Factory has a plan to relocate from residential areas in the inner city of Nha Trang since 2007. However, the locality from time to time extended the land use period in this tobacco factory area for various reasons. On February 25, 2022, Khanh Hoa Provincial People's Committee said that it had just agreed to extend the time to relocate Khatoco Tobacco Factory of Khanh Viet - Khatoco Corporation to Trang El Industrial Complex before December 31. 2023. 

BCIU was founded in 1955 as a non-profit organization made up of policy experts, strategic advisors, and trade educators. - On 11/11/2022, Tay Ninh Provincial Steering Committee against Smuggling, Commercial Fraud, and Counterfeiting (BCD 389/TN) proceeded to destroy smuggled cigarettes seized in the second phase of 2022 with the quantity of 41,643 packages with the supervision of the Tobacco destruction council, representatives of the Vietnam Tobacco Association, the Vietnam Fatherland Front of Tay Ninh province, press agencies, radio and television stations, and regional functional forces. 68

On 30 December 2014 Mr. Ho Le Nghia, Vice Director of Industrial Policy and Strategy Institute (MOIT) was appointed to be in board member of VINATABA. Since I Sept 2018, Mr. Ho Le Nghia officially acted as the Party Secretary, and Chairman of the Members' Council, replacing Mr. Vu Van Cuong, who retired according to the applicable policy.<sup>73</sup>

In August 2020, at the Party Congress of Vietnam National Tobacco Corporation, Mr. Ho Le Nghia was re-elected to be the Party Secretary of VINATABA in the new term.<sup>74</sup>

- In 2017, the Ministry of Health's official dispatch No 6814/BYT-KCB to warn about PMI-funded Foundation for a Smoke-free World Foundation (FSFW) and call to not cooperate with FSFW.
- ➢ On July 16<sup>th</sup> 2021, The Ministry of Health issued official dispatch No. 5680/BYT-KCB to Health Departments of the provinces, cities and hospitals directly under the Ministry of Health "on strengthening the implementation of the Law: Prevention and control of harmful effects of tobacco, and accelerating smoking cessation at medical facilities and disseminate information on the harmful effects of new tobacco products (e-cigarettes, heated cigarettes, shisha)". Besides, the Ministry of Health also suggested that units not cooperate with "Fund for a smoke-free world" of Philip Morris International to contribute to the implementation of Article 5.3 of the Framework Convention on Tobacco Control of which Vietnam is a member due to warning information that the FSFW fund established by Philip Morris International sent an invitation to health officers from other countries to participate in the advisory board of the global survey on the harms of tobacco.

According to the Article 41, Decree No. 67/2013/ND-CP of the Government on Elaborating some articles and measures for implementation the law on tobacco harm prevention applicable to tobacco trading, tobacco industry should report to the Ministry of Industry and Trade and Ministry of Finance.

- 3. Every tobacco supplier shall send reports on the production and types of tobacco they manufacture or trade (according to the distribution, wholesaling, retailing system) to the licensing authority and the Service of Industry and Trade of the province where their head office is situated.
- 4. Every tobacco distributor, wholesaler, and retailer shall send reports on their business to the licensing authority and the Industry and Trade Agency where their head office is situated.
- 5. Every investor in tobacco cultivation, trader of tobacco ingredients, tobacco distributor, wholesaler, and retailer shall send reports on their business to the licensing authority and the Industry and Trade Agency where their head office is situated.
- 6. Every tobacco manufacturer shall send reports on the tobacco manufacturing and trading to the Ministry of Industry and Trade and the Ministry of Finance, including: the production quantity, export quantity, import quantity, sales, sale prices, special excise duty, VAT payable on each brand.
- 7. Every enterprise that manufactures tobacco or processes tobacco ingredients shall send the Ministry of Industry and Trade reports on the import and use of machinery and equipment for tobacco manufacturing, tobacco ingredients, cigarette paper in the period, the manufacture, trading, and processing of tobacco ingredients.
- 8. The Ministry of Industry and Trade shall provide guidance the reporting regime and report forms for Services of Industry and Trade, Industry and Trade Chambers, enterprises that manufacture tobacco, process tobacco ingredients, trade in tobacco ingredients, invest in tobacco ingredients, tobacco supplier, tobacco distributors, wholesalers, and retailers. - ➢ On 21 Dec 2018, the Ministry of Communication and Information issued the Dispatch No.4324/BTTTT-PC directing the press agency to intensify communication on implementation of the TC Law and implementing FCTC related to tobacco advertising, promotion and sponsorship is still in effect.<sup>77</sup>
  - These legal documents are still effect. However, there is no specific program on creating awareness om Article 5.3.

Law No.27/2012/QH13 of the National Assembly dated 23 Nov 2012, on "Amending and supplementing a number of articles of the anti-corruption law" regulates:

Article 40- Giving presents and receiving gifts by public servants

2. Public servants must not receive money, properties or other material interests of agencies, organisations, units and/or individuals involved in affairs which they are settle or fall under their respective management.

- 3. It is strictly forbidden to take advantage of the giving and receipt of gifts to bribe or perform other acts for self-seeking interests.
- 4. The Government shall specify the giving and receipt of gifts and submission of gifts by public servants.

Decision No 64/2007/QD-TTg of the Government dated 10 May 2007 on "Promulgating the regulation on giving, receipt and hand over of gifts by state budget – funded agencies, organizations and units and cadres public employees and servants" regulates:

- Article 9- Agencies and units may only receive gifts in accordance with law. These gifts must be disclosed, managed and used according to this Regulation. Representatives of agencies and units shall refuse gifts that are given in contravention of the prescribed regime, criteria and recipients and clearly state the reasons to gift givers. When it is impossible to refuse, agencies and units shall manage and dispose of gifts according to Section 3 of this Regulation.
- Article 10- Cadres, public employees and servants may only receive gifts in accordance with law and shall acknowledge receipt with their signatures; and shall declare their incomes when required by law. Cadres, public employees and servants shall refuse gifts that are given in contravention of the prescribed regime, criteria and recipients, clearly stating the reasons to gift givers. When it is impossible to refuse, cadres, public employees and servants shall report to the head(s) of their agencies or units for disposal according to Section 3 of this Regulation.

Directive No. 21-CT / TW of the Central Committee on promoting thrift practice and waste combat regulates:

- 3. Leaders and managers at all levels who do not attend festivals and activities of cutting ribbon in the inauguration, ground breaking, opening ceremony ... if not assigned by competent authorities.
- 5. Key leaders of ministries, branches and localities do not join the delegation of enterprises going abroad or are invited by foreign enterprises. Organization and units are not allowed to organize travel abroad for officers by the state budget.

While the law is comprehensive to cover all forms of corruption, however the government still requires tobacco industry to provide fund and offer assistance to government agencies in smuggling control (mentioned in Q1, Q2, Q3, Q9) that conflicts with the recommendations of WHO FCTC. The Illicit trade protocol clearly states no TI involvement in anti-smuggling measure
