# **Background and Introduction**

Since ratifying the WHO Framework Convention on Tobacco Control (FCTC) on I June 2012, the Czech Republic has made progress in the implementation of the treaty and smoking prevalence is declining slowly. However, the progress has been hampered by interference from the tobacco industry. This is a report on the implementation of FCTC Article 5.3 guidelines,<sup>1</sup> and documents how the industry interferes in policy development and the government's response to the interference.

The main legal framework regulating tobacco products is Act No. 110/1997 Coll., on Food and Tobacco Products and on amendments to Certain Related Acts, as amended.<sup>2</sup> Implementing legal regulation to Act No. 110/1997 Coll. is Decree No. 261/2016 Coll., on tobacco products, as amended <sup>3</sup>, Decree No. 37/2017 Coll., on electronic cigarettes, electronic cigarette refills and herbal smoking products<sup>4</sup> and Decree No. 141/2023 Coll., on tobacco-free nicotine pouches<sup>5</sup>.

Directive 2014/40/EU of the European Parliament and of the Council on the approximation of the legal and administrative regulations of the member states regarding the production, trade arrangement and sale of tobacco and related products was transposed into these legal regulations. Some provisions of this Directive were transposed into Act No. 65/2017 Coll., on the Protection of Health against the Harmful Effects of Addictive Substances, as amended<sup>6</sup>. Administrator of Act No. 110/1997 Coll. including Decree No. 261/2016 Coll. is the Ministry of Agriculture. Administrator of Act No. 65/2017 Coll. including Decree No. 37/2017 Coll., on electronic cigarettes, electronic cigarette refills and herbal smoking products and Decree No. 141/2023 Coll., on tobacco-free nicotine pouches is the Ministry of Health.

The key law for tobacco products in the area of taxation is Act No. 353/2003 Coll., on consumption taxes, as amended, and its implementing Decree No. 82/2019 Coll., on tobacco labels, as amended with Ministry of finance as an administrator of the act. <sup>7,8</sup> The authority competent to control tobacco products is the Czech Agriculture and Food Inspection Authority, CFIA.<sup>9</sup> Advertising Regulation Act - Administrator of Act No. 40/1995 Coll. is the Ministry of Industry and Trade.<sup>10</sup>

In the Czech Republic, 16,000 to 19,000 people die annually as a result of smoking. The share of smoking in annual mortality in the Czech Republic is 17% as shown in the new study published by the National Institute of Mental Health.<sup>11</sup> Smoking prevalence in 2022 was 24.4% of adult population (15-64 years) – 30.5% men and 18.7% women. In the 15-24 age group, 25.4% of people smoke; in the age category 25–44 smoke 28.4%; in the age category 45–64, 26.0% smoke, and in the age category 65+, 16.9% smoke.<sup>12</sup>

According to the Czech Statistical Office, cigarette consumption in the Czech Republic was estimated to be at 1,958 cigarettes per person annually in 2019 and 1,894 in 2020<sup>13</sup>. Main tobacco companies operating in the Czech Republic (CR) are Philip Morris International (PMI), British American Tobacco (BAT), Imperial Brands and Japan Tobacco International (JTI). Revenue from cigarettes amounted to US\$236.8m in 2020. The tobacco market is expected to grow annually by about 3 percent. Figure 1 shows cigarette market share of the 4 major tobacco companies in the country: PMI Czech Republic (31,4% in 2021)<sup>14</sup>, JTI (28.9% in 2022)<sup>15</sup>, Imperial Brands (13.9% in 2019)<sup>16</sup>, BAT (22.2% in 2020)<sup>17</sup>.



Philip Morris has targeted the Czech Republic to expand its business.<sup>18</sup> Its cigarette sales are declining (17.0 billion in 2020 down to 14.5 billion sticks in 2022) but its heated tobacco products are increasing (1.7 billion units in 2020 to 2.9 billion units in 2022). While total sales of tobacco products declined in 2022, total revenues increased by 11 % to CZK 20.9 billion. Compared to 2021, the total combined market for cigarettes and heated tobacco products remained stable in 2022 at 17.4 billion units.<sup>19</sup>

Philip Morris ČR is portrayed in the media as one of the most attractive employers in the Czech Republic. It has regularly received the award Top Employer of the Czech Republic and Slovakia (recertification in 2021 for the eight time) from the international organization Top Employers Institute and several other awards, e.g.:

- Award Top Responsible Company 2021 in the "Reporting" category from the organization Business for Society<sup>20</sup>
- Award of the TOP 20 most important corporate income tax payers from the Ministry of Finance of the Czech Republic<sup>21</sup>
- The PM production plant in Kutná Hora received two prestigious awards: Certificate of the so-called AWS standard (Alliance for Water Stewardship – a standard for sustainable water management) and carbon neutrality certification, which confirms that the Kutnohorsk factory continues to reduce CO2 production.<sup>22</sup>

• The Water Supply and Sewerage Association of the Czech Republic (SOVAK ČR) is a voluntary, non-profit organization in the field of water management and sewerage for the public sector.<sup>23</sup>

The tobacco industry remains to be a strong and stable business, recognized and awarded by the Ministry of Finance for their so-called philanthropic activities during the pandemic. Following the COVID-19 pandemic, Philip Morris ČR claimed it "did not interrupt production for a moment and did not encounter any problems during it" and was able to provide financial and in-kind contribution to more than 16 million CZK within the Czech Republic.<sup>24</sup>

Philip Morris ČR also reported that it is "preparing a long-term plan for the recovery of the Czech economy in the Confederation of Industry and Transport."<sup>25</sup> PMI claimed to contribute at least 12 billion CZK to the economy in 2021, but this amount was significantly lower than the cost of the health risks and economic costs of tobacco smoking to society which are several times higher.

To portray a positive public image and win political mileage with senior government policy makers, Philip Morris ČR engaged in CSR activities. In 2021, Philip Morris ČR reported supporting to 58 organizations and spent 13 034 355 CZK in CR (\$543,098).<sup>26</sup>

Philip Morris ČR a.s. continued with a project called Youth Access Prevention – YAP, an outdated industry program that aims to prevent youth's access to tobacco and nicotine products at sale points. Philip Morris Slovakia s.r.o. continued in 2021 to support the YAP program with "Age Matters" program, which was first introduced in 1998. Although this industry-sponsored retailers' program to prevent youth access to tobacco products has shown to be ineffective, Philip Morris is still conducting it in the Czech Republic to buy public goodwill.

According to England Public Health, e-cigarettes have the potential to help smokers quit and are 95% less harmful than normal cigarettes.<sup>27</sup> There is a targeted campaign by PM to discredit the 95% number: what is written there is most certainly not true for heated tobacco. PM is trying to create the impression that EC is the same as heated tobacco and also to fight against the competition of electronic cigarettes. Even PM already has EC under the IQOS brand.<sup>2829</sup>

This is Czech Republic's third report in the series on Tobacco Industry Interference Index. Czech Republic scored 66/100 points, compared to 61 points in 2021, indicating deterioration in implementing transparency and preventive measures to protect public health policies from tobacco industry interference. While the exact manner of tobacco industry participation in policy development is not clear, there are various ways in which the industry could meddle especially in the proposed Act on lobbying is expected to come into effect in 2025. Moreover, Philip Morris ČR has relatively high CSR activities and the head of the organization is a member of the Confederation of Industry and Trade of the Czech Republic which is one of the most influential domestic business organizations in the country. As such, the national action plan must contain important points for an endgame plan, progressive tobacco taxes, plan for implementing of plain packaging as well as ban on point-of-sale advertisement or sale of tobacco products.

This report is based on a questionnaire developed by the Southeast Asia Tobacco Control Alliance. There are 20 questions based on the Article 5.3 guidelines. Information used in this report is obtained from the public domain only. A scoring system is applied to make the assessment. The score ranges from 0 - 5, where 5 indicates highest level of industry interference, and 1 is low or no interference. Hence the lower the score, the better for the country. The 0 score indicates absence of evidence or not applicable. The report includes information on incidents from April 2021 to March 2023, but also includes incidents prior to 2021 that still have relevance today.

## Summary Findings

### INDUSTRY PARTICIPATION IN POLICY DEVELOPMENT

In April 2023, the government of the approved the National Addiction Policy Action Plan for 2023-2025. This plan focuses on the use of licit and illicit substances, gambling and other forms of addictive behavior.<sup>30</sup> The National Plan cites key points of the WHO MPOWER but without concrete aims like conceptual plan on taxes, adoption of plain packaging in future, ban on point-of-sale advertisement or sale of tobacco products only in licensed shops. The Czech Republic also has no plan for Endgame, i.e. Smoke-free CR to some date.<sup>31</sup>

There are signs of communication between the Ministry of Finance and the tobacco industry in raising taxes. The Ministry of Finance, as well as the Ministry of Industry and Trade and the Ministry of Agriculture do not want to disrupt the business of the tobacco industry. They do not want to introduce tobacco control policies that could have an impact on the business outputs of tobacco companies (plain packaging, ban on advertising at the point of sale, sales in licensed stores, increasing the affordability of cigarettes).

#### 2 INDUSTRY CSR ACTIVITIES

No documented government support of CSR activities was noted in the report period. Ministries are not obliged to publish their meetings or interactions with tobacco industry.

#### **3 BENEFITS TO THE INDUSTRY**

Heated tobacco is only about a quarter of the excise tax, compared to how much people pay in the price of a pack of cigarettes. Also, the excise tax on fine-cut tobacco is lower compared to cigarettes. The tax is calculated differently according to the weight of the tobacco.

#### 4 UNNECESSARY INTERACTION

Top level government officials meet with and foster relations with the tobacco companies such as attending social action. A representative of the tobacco company is a member of Board of Directors of the Confederation of Industry and Transport of the Czech Republic.

In 2021, the Ministry of Finance recognized the twenty most important taxpayers in the country, including the tobacco industry.

#### **5 TRANSPARENCY**

A clear procedure needs to be established for publishing meetings/interactions with information that government officials may have with the tobacco industry.

#### **6** CONFLICT OF INTEREST

There is no record of newly retired senior government officials joining the tobacco industry upon their retirement in the report period. However previous examples show that there were at least four documented cases when former government officials form part of the tobacco industry after leaving position in the government.

#### 7 PREVENTIVE MEASURES

Tobacco control is a multisectoral issue, thus not only Ministry of Health but also other relevant Ministries such as Ministry of Finance, Ministry of Agriculture and Ministry of Industry and Trade are involved in this field. However, their commitments for highlighting public health policies among other priorities such as commercial aspects differ. The ministries do not currently view the adoption of preventive measures in Article 5.3 as important and even reject the discussion on the possible introduction of individual tobacco control policies in the future.

## **Recommendations**

I. The government as well as ministries 'officials should disclose all records of interaction with the TI as well as publish all contacts with TI on its website; At the very

least, this should apply to members of Interdepartmental working group on the issue of comprehensive protection against tobacco damage (MPS KOTA).

The Ministry of health should show leadership in implementing Art 5.3 by having a procedure to disclosing any interaction with the industry and making public its interactions.
 All incentives given to the industry should be disclosed.

Czech Society for Tobacco Dependence Treatment has prepared the following recommendations to reduce smoking prevalence and prevent tobacco industry interference in the country: <sup>32</sup>

- Systematically increase taxes on tobacco products not just percentage, but minimum piece rate, in line with inflation and in proportion to the average wage. Use of this income to pay for tobacco dependence treatment, control of legal trade or disposal of tobacco product waste.
- 2. Increase spending on affordable tobacco dependence treatment staffing and reimbursement for medication for tobacco dependence treatment.
- 3. Change the conditions for the sale of tobacco products: only in licensed shops = a limited number of tobacconists, not in supermarkets or elsewhere together with food. No advertising or visible display of boxes either in store/point of sale.
- 4. Educate and inform the public in terms such as heated tobacco, snus, nicotine pouches, indicating the real health risk and the risk of addiction, emphasizing the lower level of risk of products without tobacco e.g. electronic cigarettes (as opposed to heated tobacco), and only from the list registered brands that meet the given legislative conditions.
- 5. Introduce plain cigarette packaging: a box with a brown-green background, a pictorial health warning dominates, the brand name in the same font, size and color, without an unregulated surface thus the connection with the brand image is lost.
- 6. Ensure completely non-smoking public spaces, including a ban on the use of heated tobacco products.
- 7. Invest in media campaigns to inform about the adequate health risk and the risk of addiction as well as the possibilities of support for withdrawal and treatment)
- 8. Target excluded and low-socio economic status communities to monitor local conditions and offer acceptable treatment and cessation supports
- 9. Control illegal trade (paid for by taxes on tobacco products)
- 10. Support research in the areas mentioned above for the description and evaluation of specific conditions in the Czech Republic

In January 2020, the government of the Czech Republic approved the national action plan for the prevention and reduction of harm associated with addictive behavior 2019-2021. It includes key points of WHO's MPOWER,<sup>37</sup> however often in general formulation only like "plain packaging - potential discussion will be considered in future" or "taxation - regular increasing" but without any concrete vision. Although there is a gradual increase in taxes every year, there is a need to increase them substantially and suddenly to not being eroded by inflation.<sup>38</sup> Hence these measures have been delayed. It is important to emphasize that the main tobacco control policies like taxes, packaging of tobacco products and ban on advertising for tobacco products at the point of sale are under the supervision of the Ministry of Finance, Agriculture and Minister of Industry and Trade - government bodies which do not publish potential contacts with tobacco industry (TI) although representatives of ministries admit that they are contacted by TI mainly before discussing some tobacco control policy in the Parliament or the Senate.

Interdepartmental working group on the issue of comprehensive protection against tobacco damage (MPS KOTA) met regularly until 2021 when the last meeting was performed. No TI representatives are involved in this working group.<sup>39</sup>

The National Strategy to Prevent and Reduce the Harm Associated with Addictive Behaviour 2019-2027, like its previous edition, covers all drugs, legal and illegal.<sup>40</sup>

The Ministry of Agriculture, which is responsible for the decree on the packaging of tobacco products, rejected plain packaging, stating that it will wait until 2021 for a statement from the European Commission to discuss a possible introduction. The Ministry of Agriculture does not reflect the submission of evidence, an open letter from the NGO Smoke Free Partnership addressed to the Minister of Agriculture and its answer are available at the SFP's websites:<sup>41</sup>

"The approach of the Ministry of Agriculture and possible further discussions with stakeholders on the issue of the introduction of a plain packaging will continue to depend on the results of the above-mentioned evaluations and possible amendments to the Directive, which we would be required to transpose into the Czech legal order."

There was no action taken, despite what was stated previously.

Contrary to the requirements of Article 13 of the WHO FCTC to put in place a comprehensive ban on all forms of tobacco advertising, the Czech Ministry of Industry and Trade, which is responsible for regulating tobacco advertising, considers the introduction of a ban on advertising for tobacco products at the point of sale to be inappropriate: "Tobacco products are currently a legal commodity in the Czech Republic. Provided that a

The bill for protection against harmful effects of addictive substances (including tobacco smoke) allow to smoke water pipe:

"...An exception for the use of hookahs arose from voting in the Chamber of Deputies of the Parliament of the Czech Republic. According to the parliamentary proposal, smoking hookahs is common in teahouses, which are already inextricably linked with their own," said the Ministry of Health... According to the State Agricultural and Food Inspection Authority, a blanket ban on smoking could have "liquidating effects on teahouses, because the supply of hookah belongs to their characteristic features and forms a substantial part of sales," as Pavel Kopřiva, a spokesman for the iROZHLAS.cz server, wrote..."<sup>43</sup>

The Czech Ministry of Industry and Trade:

Tobacco products are currently a legal commodity in the Czech Republic. Provided that a product is legally manufactured, distributed and sold, entrepreneurs cannot be prevented from providing information and promoting this product. However, the possibility of introducing a ban on advertising for tobacco products at the point of sale was discussed with the Minister of Industry and Trade and with regard to the rights of manufacturers and sellers of tobacco products this option is considered inappropriate."<sup>44</sup> This explanation is the same explanation as that used by tobacco industry uses to oppose regulation of tobacco. This was the last statement from the ministry.

Impact on business entities: YES

Negative impacts can be expected on some businesses in the production, distribution and sale of tobacco products, electronic cigarettes, alcoholic beverages, etc., especially in connection with restricting the sale of these products and tightening the conditions related to the sale of related products. Reducing the consumption of tobacco products and alcoholic beverages can lead to a loss of profits in this industry. On the other hand, profits in other industries can be expected to increase.\*

\*Tobacco industry and the sale of tobacco products in the Czech Republic are still considered to be a normal commodity and a normal industry that should not be damaged.

Ministry of Health, Vlastimil Válek, said on the occasion of World No Tobacco Day 5/31/2023: "In nicotine pouches, nicotine enters the body in a much larger quantity, so the concentration of nicotine will probably be much higher than for smokers of standard cigarettes," added the minister. According to him, cardiologists warn that this leads to a high risk of vessel occlusion. "Switching to alternatives is not quitting smoking," added Zsofia Pusztaiová, head of the Czech office of the World Health Organization (WHO) in the Czech Republic.<sup>46</sup>

Since 2019, Philip Morris ČR a.s. became a signatory to the Diversity Charter, a project of the European Commission, the aim of which is to support and introduce diversity, flexibility and inclusion on the labor market in EU countries.<sup>50</sup>

In 2023, Imperial Brands joined the signatories of the Diversity Charter at the 2023 European Diversity Day International Conference, held under the auspices of Markéta Pekarová Adamová, Speaker of the Chamber of Deputies of the Parliament of the Czech Republic.<sup>51</sup>

Long-term funding in the field of education: The Sun for Everyone Endowment Fund or Endowment Fund of Livia and Václav Klaus.<sup>52</sup> Václav Klaus was president of the CR from 2003 to 2013, who opened a new part of the Philip Morris plant in 2010.<sup>53</sup>

Support of St. Joseph's Home in Žirč, the only in-patient facility in the Czech Republic, caring for people with multiple sclerosis. It is one of the centers of the non-state non-profit organization, Regional Charity Červený Kostelec, registered in the register of church legal entities at the Ministry of Culture.<sup>54</sup>

The Charty 77 Foundation is an important long-term partner for PM. In context of COVID-19 pandemic, Philip Morris ČR a.s. provided six hospitals throughout the Czech Republic with financial assistance in the total amount of 4.6 million CZK in 2021. Its contributions have been identified as indicated below:

- procurement of lung ventilators and personal protection equipment (surgical masks, respirators, disposable gloves, disinfection etc.).
- ozone generators for ambulances of the Medical Rescue Service of the Central Bohemian Region.
- donated CZK 200,000 to the Kutná Hora Hospital, as part of the Kolín Regional Hospital, a.s.,
- a hospital in the Central Bohemian Region, for the purchase of personal protective equipment. In addition,

 funding to Czech Association of Nurses for the recovery activities of nurses and other non-medical hospital staff involved in the care of patients with COVID-19 disease."<sup>55</sup>

Three Prague hospitals (one of them is state) received a donation of over 7 million CZK to fight coronavirus. The extraordinary fund was managed by the Charter 77 Foundation - Barriers Account.<sup>56</sup>

In the first half of 2022, Philip Morris ČR reported that 5.6 million CZK were allocated to the program of aid to refugees from Ukraine for the education of Ukrainian children, financial aid to schools and school facilities. In 2022, Philip Morris donated 1 million CZK to restore the urban forest in Hodonín, which was destroyed by a tornado in June 2021.<sup>57</sup>

Key topics of Philip Morris in the public space: Comprehensive media coverage and an extensive network of direct relations with media of all types throughout the Czech Republic (general / lifestyle / business)

- Ongoing media support for the launch of new products and all relevant company news
- Support of the Philip Morris ČR 30 gala to celebrate the anniversary of 30 years of activity on the Czech market, which took place on November 3, 2023 in Prague and was attended by over 70 key partners<sup>58</sup>

### **INDICATOR 3: Benefits to the Tobacco Industry**

 The government accommodates requests from the tobacco industry for a longer time frame for implementation or postponement of tobacco control law. (e.g. 180 days is common for PHW, Tax increase can be implemented within 1 month) (Rec 7.1)

In the official report to the COP, the government reported that the Ministry of Health promoted Article 5.3 during consultations on the preparation of the draft act on lobbying. The government approved draft rules in February 2018 but the final draft act was submitted only at the end of 2018.<sup>59</sup> This Act on lobbying from the Ministry of Justice was supposed to enter into force on I January 2021 but after Legislative Council hearing in

May 2023, the current regulation is expected to come into effect in 2025. <sup>6061</sup> The Act is a general law on lobbying and not specifically on Article 5.3.<sup>62</sup> The planned entry date of the law on lobbying, conflict of interest was on 1 January 2021, but the law has long overdue and even after 2 years it is uncertain whether it will be approved by the election.<sup>63 64</sup>

Tax on heated tobacco is only about a quarter of the excise tax, compared to what people pay in the price of a pack of cigarettes. The tax for heated tobacco is calculated differently – according to the weight of the tobacco.<sup>65</sup>

Flavored cigarettes including vanilla, blueberry and other varieties deemed to appeal to young demographics had been banned under EU regulations from 2018. Menthol cigarettes also fell under this ban, but were given a two-year exemption.<sup>66</sup>

The Ministry of Finance wants to gradually raise the tax on tobacco by a quarter. However, the tax on heated tobacco should continue to grow more slowly. In addition, the rate of excise duty on tobacco alternatives is low, and therefore its increase will not increase the final price that much.<sup>67</sup>

Tobacco promotion is still allowed, including contests. BAT's electronic cigarettes are promoted online and sold via a special system for retailers.<sup>68</sup>

Philip Morris, and Jiří Belinger, Vice-Chairman of the Association of Small and Medium-Sized Enterprises and Crafts CZ.<sup>76</sup>

Confederation of Industry and Trade of the Czech Republic, accompanied the Minister of Foreign Affairs, Jan Lipavský, on his official visit to Delhi and Mumbai from Sunday, February 26 2023. Imports from India to the Czech Republic, on the other hand, are dominated by textiles, pharmaceutical products, electronics, metallurgy, chemicals, plastics, engineering, coffee, tea, spices and tobacco.<sup>77</sup>

As a lobbying organization representing the interests of employers in the Czech Republic, the Confederation of Industry and Trade of the Czech Republic (SP CR) engages in active lobbying in the Parliament of the Czech Republic, state and local government bodies. It organizes information campaigns on topics that are important for the development and competitiveness of the economy. SP CR has an irreplaceable role in lobbying at the national level, especially as a representative of the business sector in the Council of Economic and Social Agreement (Tripartite), in which it is a worthy partner to representatives of the government and trade unions. The expert team deals with tax issues from the point of view of the impact on the business sector, processes comments on the proposals being prepared and offers partial or conceptual ideas for improvement.<sup>78</sup>

5/2023: Members of the most influential domestic business organization the Confederation of Industry and Trade of the Czech Republic will elect new leadership. Andrea Gontkovičová, a head of Philip Morris ČR, will seek the post of vice president.<sup>79</sup>

"Experts agree: The public does not know about water problems in the Czech Republic": With the support of the Ministry of the Environment, a new communication platform Water, the basis of life, is being launched": Director of External Relations and Communications of JTI is also the chairman of the board of Water Foundation of Life. Under the auspices of the Minister of the Environment, he founded the vodazakladzivota.cz server.<sup>80</sup>

The Mayor of Prague Zdeněk Hřib endorsed the Clothing Bank of JTI. "I welcome and am very grateful for the Clothing Bank as an initiative created in collaboration with the network of food banks. I should mention that Prague's residents can also receive assistance from a furniture bank, which the city has established during this election period."<sup>81</sup>

There is no publicly available record of the national government accepting or entering into a partnership or agreements with the tobacco industry.

However, at the sub-national level, the mayor of Karlovy Vary signed a cooperation agreement with PMI's Czech subsidiary in May 2019 to become "the first spa town in the Czech Republic without smoke." The official City Hall newsletter, "Radniční listy," has promoted the tobacco company's collaboration with the municipality. It also published an article directing smokers to the PMI-registered website unsmokeyourworld.com.

At the 57<sup>th</sup> Karlovy Vary International Film Festival in August, PMI installed an interactive exhibition called World Without Smoke Laboratory, where visitors could learn about cigarette alternatives, including IQOS. The tobacco company was listed in a press release as an official partner. <sup>82 83</sup> The 57th Karlovy Vary International Film Festival is also supported by the Ministry of Culture.
